Prior to these standards internal auditors were being guided by the 2017 standards.

Following the release of the 2024 Standards Internal Audit Functions are required to:

- Train Internal audit staff and Members of Board Audit Committee on these new standards
- Update Internal Audit Manuals to be aligned to the new Global Internal Audit Standards.
